












## Assistance Providers

NC Association of County Commissioners (NCACC) https://ncacc.org/

Founded in 1908 as advocacy organization for counties to the NC General Assembly. Proponent of regionalization to share water and wastewater assets, especially in times of crisis.

NC Association of Regional Councils of Government (COGs) https://ncregions.org/

Created by the legislature (1960s) and are governed by local governments. Services include grant writing/admin, GIS services, financial admin, and other services. COGs are subject to LGC oversight just as local governments.

Advocacy solutions for member municipalities with ability to influence statewide policy. New program of municipal operations consultants working with members to discuss local challenges and solutions, including utility systems.

Serves 80 rural counties and 415 municipalities. Non-profit organization that emphasizes local leadership development and takes advocacy positions for needed policy changes.

NC Rural Water Association (NCRWA) https://ncrwa.org/

Provides onsite technical assistance and training to water and wastewater utilities statewide. Areas of assistance include operation, maintenance,

compliance, finance, and management systems. Provided in partnership with USDA, EPA, and DEQ.

Advising, training, applied research services, and development of resources for utility managers and boards. Focus on finance, management, regionalization, and best practices of water, wastewater and stormwater services.

Provide technical assistance focusing on managerial aspects of utilities with populations of less than 3.5k; can assist those up to 10k. 100% federally funded. Five staff create long-term relationships with communities.

Work with LGUs through its Debt Management Section and Fiscal Management Section. Maintain Unit Assistance List of LGUs with financial issues.

Seven Regional Operations offices focus on surface water and groundwater protection and regulation. Conduct permitted facility inspections and incident investigations. Often advise staff of small utilities on wastewater issues.

populations between 2.5k and 10k people. Historically funded expansions but more recently funding has shifted to rehabilitation.
