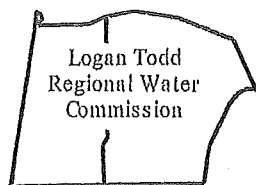

1. Commission formed in 1995.
2. Studied alternatives, planned project 1995-1998,
3. Received State grant of \$2,000,000 in 1998,
4. Contracted to supply treated water to 12 systems in 1999.
5. Began design of regional water system in 1999.
6. Initiated construction of raw water line in 2000.
7. Sold \$30M bond anticipation note (BAN) in August 2000.
8. Completed construction of raw water line in May 2001,
9. Completed design of system in June 2001,
10. Received bids on water plant, intake, transmission lines May 2001 through January 2002.
11. Started water plant construction June 2001.
12. Sold additional \$40M BAN in October 2001.
13. Began production in 2003.

2015 to Present

- Signed a contract with Springfield, Tennessee.
- Cost of Springfield Addition - Estimated \$26,000,000 to begin construction in late 2017. Funding is already in place and divided between Rural Development, KIA, Bond Issue.
- Springfield will purchase enough water over a 40 year period to pay for the line at 2.3 million gallons per day.
- Current wholesale rate \$3.91 per 1,000 gallons. All systems pay the same rate regardless of location.
- We are currently producing an average of 4,000,000 gallons per day. This rate allows us to put in reserves approximately \$500,000 a year and we have not had to borrow a dime for maintenance and upkeep in 14 years of operation.
